Thank you for the detailed response. October is very close, we need get organized. Please let me know your thoughts on the following suggestions to start the ball rolling. I'll also try to set up a call for tomorrow morning when your calendar is open.

- 1. Confirm we have sufficient funding for experts to travel and attend out proposed meeting in October. This will not be insignificant.
- 2. I will inquire into Sir Colin Berry's availability and interest in an October 22nd meeting (or Jack Mandel if Sir Colin is not available), to present a seminar on the history and activities of the EU Glyphosate Expert Advisory Panel.
 - a. I will likely prepare this presentation and send to him to change/adapt as he sees fit.
- 3. Contact Wallace Hayes to determine his availability and fees for attending the meeting.
- 4. Talk with Dan Goldstein about contacting the medical toxicologists in the region about attending the October 22nd meeting (hopefully with the knowledge of Sir Colin and Wallace Hayes attending).
- 5. Check availability of experts in Brazil;
 - a. João Lauro Viana de Camargo (Professor of Pathology, UNESP Medical School, Botucatu, SP Brazil) who is currently working on a project for the EU Glyphosate Task Force, reviewing the toxicology carcinogenicity study set and coauthoring a manuscript for peer reviewed publication.
