This is in reference to a presentation by Jack Housenger.

He was very guarded.

A couple of other observations:

I asked him about EPA's unwillingness to support its own decisions (i.e. sulfoxaflo). He answered by saying that EPA had originally planned to issue a conditional registration of sulfoxaflo, but decided against it due to criticism from the GAO report. Instead, they decided to issue it as a section 3, but with reduced rates. In retrospect, he thought the conditional approach would have been better. In other words, he didn't answer the question.

He also discussed the glyphosate/cancer issue by saying they would issue some sort of risk assessment and have it validated by the SAP.
